5	Does your school have measures to identify crisis warning signs?			
6	Does your school have a central reporting system that allows students, parents, teachers, and others to anonymously report threats, bullying, and other concerning behaviors?			
7	Does your school conduct site assessments to help inform its emergency management, safety and preparedness plans?			
8	Does your school have a lockdown procedure or process in place?

16	Does your school engage diverse stakeholders in crisis management planning?			
17	Is your school offering online safety education programs for students, teachers, staff, and families?			
18	Is your school implementing a wellness program to support affected students/staff/teachers' emotional health?			
19	Are you aware of any grants or government funding you may be eligible for to support crisis preparedness at your school?			
20	Do you have updated emergency contact details for your employees and students?			
21	Do you have grants organizations and government entities on your key emergency contact list?
